I have knowledge of the facts listed in statement of facts based on my review of available Columbus Division of Police Reports, which were completed by Columbus Division of Police Officers acting in their official capacity and as a part of their official duties.
Summary Statement of Facts in Support of Probable Cause:
On September 27, 2023 Ms. Jennifer Cheeks called Columbus Police to her home because she found text messages on her 13 year-old son's cellphone from his mental health counselor/social worker: 23 year-old Ms. Payton Shires. Ms. Cheeks believed something inappropriate was happening between her son and Ms. Shires after seeing messages asking if he had deleted the videos, and if his mom had seen the videos or messages. Ms. Cheeks gave the phone to officers who turned it into the CPD Property room for evidence.
On October 4, 2023 Detective Specht got a search warrant for Ms. Cheeks' cell phone and found a video of Ms. Shires and the 13 year-old victim M.C. having vaginal intercourse. Detective Good conducted an audio recorded interview of M.C. and he admitted to having vaginal intercourse with Ms. Shires 3 times and receiving fellatio from her one time all during September of 2023 in various locations in Columbus.
On October 5, 2023 Ms. Cheeks did a controlled 3-way call with detectives and Ms. Shires, during this phone call Ms. Shires admitted to Ms. Cheeks over the recorded call that she had vaginal intercourse with M.C. 2 times and performed fellatio on him one time. Ms. Shires is over 10 years older than M.C.
