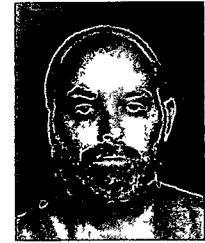

Probable Cause Affidavit

Before me this date personally appeared MENDOZA, JAHRON (PD1318) who being first duly sworn deposes and says that on 25 day of December (year) 2023 at 4963 NW 110TH WAY, CORAL SPRINGS, FL 33076 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

**FIREARM IN PLAIN VIEW IN THE PRESENCE OF ONE OR MORE PERSONS. DEFENDANT STATED TO THE NEIGHBORS THAT HE COULD TEACH HER 17 MONTH OLD GRANDCHILD HOW TO USE A FIREARM AS HE WAS DISPLAYING THE FIREARM TO HER. DEFENDANT IS PERSONALLY KNOWN TO THE NEIGHBORS AND SHE BELIEVES HE WAS INTOXICATED. CALLER ADVISED THAT SHE OBSERVED THE DEFENDANT WALK AWAY FROM HER RESIDENCE WITH THE FIREARM STILL IN HIS POSSESSION. CALLER STATED THE NEIGHBOR ADVISED SHE HEARD WHAT SHE BELIEVED TO BE A GUN SHOT. CALLER STATED THAT THE DEFENDANT HAS A DRINKING PROBLEM.**

**UPON ARRIVAL THE MALE WHO WAS LATER IDENTIFIED AS THE DEFENDANT WAS OBSERVED WALKING INTO AN OPEN GARAGE DOOR. THE DEFENDANT WAS SEEN OPENING A SECOND GARAGE DOOR, WHERE HE WAS THEN SEEN HOLDING A FIREARM. THE DEFENDANT THEN SHOT MULTIPLE ROUNDS INTO AN UNKNOWN DIRECTION RECKLESSLY AND NEGLIGENTLY.**

**COMMANDS WERE GIVEN TO THE DEFENDANT TO DROP THE WEAPON AND WALK TOWARDS CSPD OFFICERS. THE DEFENDANT FAILED TO COMPLY AFTER MULTIPLE REQUESTS TO DROP THE WEAPON. EVENTUALLY THE DEFENDANT DROPPED THE WEAPON AND BEGAN WALKING TOWARDS CSPD OFFICERS. THE DEFENDANT WAS GIVEN COMMANDS TO TURN AROUND AND KEEP HIS HANDS UP, TO WHICH HE FAILED TO COMPLY. EVENTUALLY THE DEFENDANT WAS TAKEN INTO CUSTODY AND DID NOT COMPLY WITH ALL GIVEN COMMANDS.**

**AFTER TAKEN INTO CUSTODY THE DEFENDANT APPEARED TO BE INTOXICATED WITH WHAT WE BELIEVED TO BE A CONSUMPTION OF ALCOHOLIC BEVERAGES AND WAS SEEN IN A PUBLIC PLACE. THE DEFENDANT LATER STATED THAT HE HAD BEEN DRINKING. DEFENDANT APPEARED TO BE INCOHERENT AND HIS TRAIN OF THOUGHT APPEARED TO NOT BE LOGICAL.**
